Our Speaker is His Honour Justice Christopher Simmonds – Christopher Simmonds has been a Family Circuit Judge since the 3rd April 2018 now sitting at Bournemouth. He was originally a District Judge appointed in 2010. He sat in the Principal Registry of the Family Division until his transfer to the Western Circuit in November 2015. He is a nominated Judge of the Court of Protection and the lead Court of Protection Judge for the Southwest, a former Commissioner of the Judicial Appointments Commission and former Course Director at the Judicial College (Family). Before being appointed he was a Solicitor and Partner in the firm of Davis Simmonds & Donaghey specialising in Public Law Proceedings and a member of the Children Panel. He has written numerous articles on family law to include section 38(6) Applications and Secure Accommodation Orders and is one of the editors of A Practical Guide to Family Proceedings: Blomfield and Brooks: Sixth Edition (Bloomsbury Family Law) 6th Edition.
