Looking back on the President's column this time last year Mark opened with the words "a New Year a new decade". What a start to the new decade we have witnessed! Little did we realise this time last year what was to come and nor did we foresee a year later we would have faced such interruption to our businesses, social world and health. However, despite such an unexpected "bolt out of the blue" I am pleased and proud to say that your Society has continued to be proactive, supportive and focused on maintaining strong links with all our members. Despite not being able to enjoy the traditional social events and lecture series your committee, and Mandy and Julie in particular, have been active in arranging innovative ways to maintain educational and social events for our members. In the last 12 months we have held no less than 36 training events coupled with a Frazzled Friday event at the Marsham Court Hotel and a thoroughly enjoyable, albeit remote, gin tasting evening – thankfully the gin itself was not remote! Plans are on the horizon for a remote quiz and remote wine tasting evening by April - see later in this Magazine.

There has been terrific support for the continuing membership of this Society with most renewal subscriptions already having been received for this year and 25 applications by new members received since Christmas. Our Wellbeing and Diversity Sub-committee has continued its work virtually and there have been further opportunities for remote socialising including our wellbeing catch up meetings. Last week we had an interesting opportunity to hear from Donna Smith with her Burn Bright (but don't burn out!) Masterclass which had an encouraging number of participants.

I represented the Society at SAALS (The Southern Area of Law Societies) meeting in January. Most commented that very little had happened in their area since lockdown and there was a fairly negative air. Feedback from other southern local law society areas included reports of lack of renewal of memberships, cancellation of all events and one with no President or President Elect. Having heard this, our Society's activity and the support of members is so positive and encouraging. We have always been a tight-knit and proactive local law society and it really shows, particularly in difficult times. When I reported on what we, in the BDLS, had undertaken since lockdown, and the events that had occurred, representatives from some of the other Southern Area Law Societies were most impressed. In fact, amusingly a representative of another local law society somewhat removed from here enquired over the remote chat whether it was possible for him to join the Bournemouth & District Law Society!

The Property Group, chaired by Martyn Hudson, has been incredibly active in representations to the Chancellor and to

a number of MPs on behalf of members with regard to the stressful pressures the deadline the SDLT holiday is causing and the need to review the whole scheme. Martyn will provide details of this in a separate article but my thanks go to him and all the Property Group for their sterling work and time devoted to representing our members on this important issue.

The Law Society has certainly been active in local months. The two resolutions put to the whole of the Law Society membership for proposed changes of governance were approved in January with 83.3% of the vote being in favour of the new constituency proposals and 77.2 % in favour of limiting the term during which council members can serve. Whilst, thankfully, the Dorset Constituency remains unchanged (and thanks go to Tim O'Sullivan for his influence in this) it does mean in the future we will not be able to continue with the same Council Member for more than 12 years.

As I write this article, the Law Society has just contacted local law society Presidents with a view to deepening the engagement between the Law Society and local law societies and has drafted a set of commitments that they want to make to all local law societies designed to improve engagement and support for members. However, as their survey feedback is required to be given within a week the 'depth of engagement' appears unconvincing and gives little faith that their intentions can lead to a full and valid reflection on the views from our membership. However, I will be responding as best I can on your behalf.

In turn, the Legal Services Board (LSB) have published their proposed strategy for the coming years setting out the challenges, as they see it, of tackling "unmet legal needs across large parts of society" and "empowering consumers to obtain high quality and affordable services". Whilst no detail appears to have been provided the LSB is proposing "a reshaping of legal services". This again has a very short consultation period and by the time this magazine goes to print the deadline will have passed (5 February) but your Society has circulated these details for any individuals who wish to comment. The Law Society itself will be submitting a full response.

At the time of writing we are still in lockdown and there is no sign when resumption of "normality" might occur, nor when we might hope to have any annual luncheon or dinner; nor, indeed, hold our next AGM. I thank you for your support shown to me so far over the year; I may write in the next column or by then it may well be your new President, Neil White, whom I know you will welcome and provide your continuing support.

CHRIS REEVES - POOLE TOWN FOOTBALL CLUB SURVIVING COVID



Chris Reeves, Chair of Poole Town FC

Ever since I was 13 and got completely hooked on semi professional football in general and Poole Town Football Club. in particular, I always wondered what pleasure anyone could derive from a Saturday afternoon or Tuesday night between August and May without being at a game. Such a pointless waste of time to be doing anything else I have always thought and then along came Covid 19 and the barren waste of

life without football really hit home! How I yearn for matchday activity to return.

Apart from a few years in the late eighties, I have been either Chairman or vice-Chairman of Poole Town FC since 1978 and am very proud to be well into my second stint as Chairman. At Poole, we are well used to an array of different problems, quite apart from the recruitment of players/managers/bar and catering staff/stewards/groundsmen/physios/photographers/ match day volunteers/PA announcers/programme sellers/ turnstile operators and a whole host of other roles. Not to mention the endless issues associated with securing sponsorship/advertising and other revenue streams to ensure that we can keep our financial heads above water. No problems in the past though have ever completely stopped us playing! No problems in the past have ever completely stripped us of our ability to trade! Concerns about cashflow issues areme a staple diet for the vast majority of Clubs outside the Premier League at the best of times but now...

Challenges are there to be overcome though and back in March during the first lockdown, the first thing to analyse was the Government's furlough scheme—in terms of maintaining our contractual liabilities to our players that was key and a huge relief. Football at our level just cannot operate without match day income so the government's help in this respect was a fundamental essential if we were to survive in anything like the same state as we had entered the year.

As a member of the FA Council I was involved in the broader picture in addition to having to focus on Poole's problems and very quickly due to the financial realities inherent in having to pay bills whilst not being able to trade, the semi-professional

season 2019/2020 was declared null and void by the FA in an effort to stem the flow of trading losses.

As the months wore on towards a new season and against slightly relaxed restrictions my fellow directors and I had the difficult task of setting a budget for the new campaign. Where were we going to get sponsorship and advertising revenue from in the dire financial climate that the restrictions had created? How could we justify repeating the playing budget so that our long serving manager Tom Killick (17 years in the job!) could put together a competitive squad? Not easy!

So what did we do? Well first off we decided that if we couldn't play matches and promote our sponsors/advertisers in that way then we would look to provide as good a social media exposure as we could. We set about upgrading what we did online and went out to our friends in the business world not asking them to support us but rather asking them what we could do to support them. We put together video clips and regular social media postings to promote our sponsors and to our delight the policy had exactly the desired effect.

The business community responded well to our approach and the ensuing dialogue with each advertiser enlightened them as to our problems and the support we have received as a result has exceeded our expectations to a point where we feel that as a business we are in a reasonable shape to go forward again once the restrictions are lifted and we can play again.

The side that Tom put together on his reduced budget produced the goods in a superb manner during the games that we were able to play at the start of the 20/21 season and when the lockdown brought an end to games Poole Town stood proud at the top of the table so at very least the league table looks good every time it is printed these days!

We have had to think outside the box, adapt quickly to the problems presented to us and ensure that we are in a state of readiness to spring back to life as soon as practicalities permit. It is not easy running a semi-professional football club as a hobby! Remember the next time you go to a game that it could not have taken place without a host of volunteers having spent huge swathes of time to enable it to happen!

At the request of the main Committee, and the President of the Bournemouth & District Law Society, I was tasked to engage in correspondence with the Chancellor of the Exchequer's Department, in the hope of being influential in some way in getting him to "see the light" with regard to the dangers and the damage that he will cause to the property industry if the Stamp Duty holiday currently in play, comes to an abrupt end at the end of March.

At the time of preparing this article, the latest email has yet to be responded to, but any subsequent response may be added at the end, just so that this article is up to date at least by the time it is published, which will be at the start of March. Membership Experience

A problem with the Law Society is that its grass root members – you and me that is - sometimes have difficulty in seeing its relevance. The Society does recognise this as a problem and there is a major push underway to improve the 'membership experience'. As a first step the Society is reviewing its relationship with local Law Societies to see how it can be improved. Debates will be taking place and proposals are likely to be forthcoming. Some will say they have seen this all before, but there does seem to be genuine wish to improve the relationship. Many local Law Societies up and down the country are keen to get involved and I shall be making sure the views of our BDLS will be listened to.

New Law Society webpage and Law Society Connect

If you have not done so already, do log onto the new Law Society webpage. If you indicate your preferences, it should tailor its contents for you. If you are 'a small practitioner' (not in height, but up to a four-partner firm), also look at and join 'Law Society Connect' (which will pop up when you sign in). It is a chat room to help you to discuss issues of the moment. Even if you are in a bigger firm, it is still worth a look. Let me know what you think, as if it works it might be rolled out for other groups.

12 years maximum term

Meanwhile, the profession has voted - although in remarkably low numbers. With a turnout of around 6%, we voted through two motions. The first is that Law Society Council members will have a maximum term of twelve years. Any Council member who has served longer will not be able to stand again. Some long-standing members will therefore be ousted when their current four-year terms end. One can see the benefits of getting new blood in, but it does mean, for better or worse, Council will lose a number of experienced Councillors.

New Subject based Council seats

The second motion removes around 15 geographically based Council seats and replaces them with seats representing specialist work subjects and minority groups. The thinking is to make Council more representative of a changing profession. Again, this change will be implemented over the next few years as seats fall empty and, you never know, you might get access to an additional Council member or two.

Campaigns and Consultations

One has to give credit to the immense hard work of those dealing with policy issues at the Law Society. They are dealing daily with a vast range of issues being thrown up by the pandemic (from work related guidance to the great problems with the court backlogs – particularly in crime) and by Brexit and all the legal issues flowing from that. A recent survey among MPs showed the Society is seen as one of the most credible and persuasive of outside influencers.

BURNING BRIGHT (NOT OUT!): CHANGING THE DELUSION THAT YOU NEED TO BURN OUT TO SUCCEED

That will do.....or will it?



You have a mobile phone, right? And from time to time (most days in fact), it needs charging because the battery is low. Sometimes, you charge it overnight whilst you are sleeping and sometimes you charge it on the go, often just topping it up enough to get you through the day.

It is this second approach that caught my attention recently. I was delivering a workshop on my Burn Bright Activation Programme and I had forgot to charge my phone overnight. So, I put it on charge whilst delivering the workshop and part way through, I checked the level of battery life which read 78%. 'Fab', I thought, 'that will do.'

Now, on the face of it, this is rather a mundane story to be telling you. However, it occurred to me that this is often how we treat ourselves and our self-care. Often, when I spot the signs of needing to recharge myself i.e. my battery is running low, rather than allowing myself to get fully topped up regularly, I take an ad hoc 'that will do' approach. Grabbing an early night here or there, treating myself to the occasional soak in a nice hot bath. Reserving what I would call my 'full recharge' until the next available holiday in the sunshine (who knows when that is likely to happen!) Then, I wonder why I never feel fully energised and that I seem to be running on empty most of the time?!

Why is it that we spend our weeks living for the weekend and our months living for that one- or two-week holiday that is coming up? Also, why is it that, even when we have had the weekend or the holiday, it is often the case that we come back only marginally replenished before we head back into the busyness of day to day life only to start the next countdown until we can get away from it all again?

I think it is because we take the approach of 'that will do' when really, it won't! We tell ourselves we do not have time for ourselves and that there are more important things we 'should' be doing. Our wellbeing and self-care are very often at the bottom of our list of priorities if it is even on there at all!



On the Burn Bright Activation Programme, I introduce my clients to the concept of their Burn Bright Bank Account. It is like a regular bank account with deposits and withdrawals but with energy for currency rather than money. The point of the Burn Bright Bank Account is to raise awareness of the deposits we make towards our wellbeing and self-care and the withdrawals we take away. All too often, there are way more withdrawals than there are deposits and that is where the problem lies.

It is clear to me that, if we continue to settle for anything less than 100% when we recharge ourselves, we are never able to fully withstand the daily withdrawals from our Burn Bright Bank Account. This then has a negative impact on our account balance and consequently, we end up in overdraft, more commonly known as burnout!

So, next time you plug your mobile phone in to recharge, pause and ask yourself – 'when was the last time you allowed yourself to be fully recharged?'

RESILIENCE – HOW TO KEEP GOING

Resilience is the ability to adapt and bounce back when things do not go as planned – and is a key quality we need to foster in order to keep going over the coming days and months and face the inevitable challenges ahead. Resilience is vital in order to survive and thrive in the current climate and resilient people will be able to utilise their skills and strengths to cope and recover from problems and challenges.

In his best-selling book, The Resiliency Advantage, Al Siebert writes that "highly resilient people are flexible, adapt to new circumstances quickly, and thrive in constant change. Most important, they expect to bounce back and feel confident that they will." That expectation is closely linked to a general sense of optimism – not a quality lawyers are trained to develop – but it is nevertheless possible to develop the right mental attitudes to cope and even flourish when the going gets tough.

Key qualities of a resilient person

- Holding positive views of yourself and your abilities
- Being able to make realistic plans and stick to them
- Having an internal locus of control attributing your success to your own behaviour rather than luck or fate
- Being a good communicator
- Viewing yourself as a fighter rather than a victim.
- Having high emotional intelligence and being able to manage your emotions effectively



Ten tips to build resilience:

- I. Recognise that this situation is temporary things WILL change over the coming weeks and months.
- 2. Don't give in to negative thoughts about the future. Challenge them and ask whether those thoughts are true or realistic.
- 3. Learn to see challenges, mistakes and failures as valuable learning experiences. If we can survive this we will be stronger.
- 4. Use humour to defuse and downplay difficulties. Laugh at yourself, and situations, laugh with colleagues, friends and family.
- 5. Be flexible. Recognise that nothing stays the same and don't get too stuck in thoughts of how things used to be
- 6. Take care of your physical and mental health. Get enough sleep, exercise and eat well. When your physical self is in good shape, you are less fragile.
- 7. Take time off work, use your holiday entitlement and make sure you take breaks during the working day.
- 8. Recognise that a bad situation is usually temporary.
- 9. Don't extrapolate one bad situation into another and catastrophise one day at a time, it is pointless worrying about the future.
- 10. Give yourself a pat on the back when things go well. Be kind to yourself, and forgive yourself when things go wrong. Treat yourself occasionally.

The Wills Act 1837 (Electronic Communications) (Amendment) (Coronavirus) Order 2020 (2020/952) came into force on 28 September. It amends the requirements for execution under Wills Act 1837 on a temporary basis.

The existing s9 becomes s9(1) and a new s9(2) provides as follows:

"For the purposes of paragraphs (c) and (d) of subsection (I), in relation to wills made on or after 31 January 2020 and on or before 31 January 2022, 'presence' includes presence by means of videoconference or other visual transmission."

Anyone thinking of taking advantage of virtual witnessing should look at the "Guidance on making wills using video-conferencing" which the government published on 25 July 2020 and the Law Society's Practice Note.

There are a number of problems with the process.

- (I) Both witnesses must be virtually present when the testator signs or acknowledges an earlier signature. Witnessing prerecorded videos is not permitted the witnesses must see the will being signed in real-time.
- (2) The will must then be transported to the witnesses who must physically sign the will in the virtual presence of the testator, and, if possible, in the virtual or physical presence of each other. The will is not valid until all three parties have signed. There is, obviously, a real danger of the testator dying before the process is complete.
- (3) The testator will write in the date on which he/she signs and the witnesses will each write the date on which they sign.
- (4) The attestation clause should be amended to recite the fact that virtual witnessing took place.
- (5) The witnesses and the testator must be able to see the act of signing as opposed to just the head and shoulders. It's surprisingly difficult to organize this. Have a go yourself to test

it out.

(6) Government advice is to record the process if possible.

The government advice said: "The use of video technology should remain a last resort, and people must continue to arrange physical witnessing of wills where it is safe to do so." Given the cumbersome nature of the process anyone who can arrange physical witnessing would be better off doing so. Having said that, there will be occasions when the procedure will be useful. For example, where someone has tested positive for Covid 19 and wants to proceed with execution safely or where someone lives in a remote location and arranging witnesses is difficult.

If your firm is going to oversee virtual execution there are a number of things to consider.

What level of fee earner should be allowed to do this?

Who is going to be responsible for storing the recording? If you, check with your IT department for problems.

The Law Society Practice Note suggests checking that your insurance will cover virtual execution.

Because of the lack of face to face contact, make very full attendance notes dealing with capacity, knowledge and approval and undue influence.

Conclusions

What do we think of the provisions? A lot of work for contentious practitioners in the future I would hazard.
