SAFFERY CHAMPNESS - JAMIE LANE

Saffery Champness Chartered Accountants look at what are the biggest worries for new partners?

Promotion season is approaching; the time of year where the votes are being cast on who might be lucky enough to join the partnership ranks. The process can be daunting, with future career progression dependent upon the outcome of that meeting.

But it's not all one-way, partnerships still need to continue to work hard to attract talent at all levels, but particularly at installing the next generation of partners who, one day, will lead the practice. As the age demographic of partners shifts, so does the view of what partners want and what 'partnership' should be. At our recent webinar we polled our audience of upcoming partners and revealed that there are still some key questions that remain unanswered about this big move.

What is the biggest worry for new partners?

In our recent webinar for new partners, we asked our audience what their biggest concern was about becoming a partner. With nearly one third of the vote, the key concern continues to be the impact of losing employment status and the protections that can afford the individual. Dependent on your attitude to risk, moving from an employed position to a self-employed one can sound particularly worrying. One way for partnerships to mitigate this is to allow potential partners to see the protections that they would be afforded by a Members Agreement. This, of course, depends heavily on the type of partner, as there are many types and many different partnership arrangements, so firms would do well to ensure their next cohort fully understand the provisions of the partnership.



Do you even want to be a partner?

The most surprising concern raised, as the audience were all aspiring partners, was that nearly a quarter said that they were unsure whether it was the right firm or role to be in. Clearly, some partnerships need to do more to demonstrate the benefits and rewards of joining the partnership. Becoming a partner is a hard transition, but it is one that is usually extensively planned by the existing partners, either through growth ambitions or through succession challenges.

How many plates will you have to spin?

The third top concern among our audience was having to take on new internal responsibilities within the firm – let's face it, it's not unusual for the most junior partner to have the 'opportunity' to take on internal responsibilities that have been handed down to the last one through the door for a number of years.

Ultimately, the role of the partner, especially in SME partnerships, is wide ranging. The amount of 'plate spinning' required across many different areas, such as business development, strategy, HR, and technical to name a few, leaves you questioning, when do you have the time to earn fees. But whilst the transition to partner can take time and lots of energy, it is still an incredibly rewarding role.

THE COUNCIL MEMBER'S REPORT

SOLICITOR INDEMNITY FUND SUCCESS!

After strong campaigning by the Law Society – including a submission by the BDLS as well - the Solicitors Regulation Authority (SRA) have agreed to delay the closing of SIF for a further year; to give time for further consideration. You will recall SIF is a fund of some millions (left over from the mutual insurance fund previously run by the Law Society) and is currently used to cover insurance claims that arise after the expiration of the six-year post insurance cover that has to be bought by firms that close without succession. It is a vital safeguard for sole practitioners in particular - as the market does not offer insurance cover in these circumstances. The extension of time is an indication that the SRA is prepared to look again at whether or not the fund should be closed – but with no guarantee as to what the final outcome will be.

On **Criminal Legal aid**, the Law Society also campaigned strongly for the Government to accept the recommendation of the Sir Christopher Bellamy review (which some of our local members made contributions to) that the legal aid rate for criminal work must increase by 15% as an absolute minimum. The Government announced they accepted the recommendations and the rate would be increased by that amount – only for us to find that when the small print was investigated, the rate increase for Solicitors was far less. Campaigning continues.

Another success, less high profile but still important, has been an influencing campaign by the Law Society which has persuaded the government to retain the Judge's discretion as part of its proposed amendments to the **Judicial Review** process.

The **War in Ukraine** has also thrown up major and difficult ethical issues for those firms that had offices in Russia or who find some of their clients are now sanctioned. All firms involved closed their Russian offices shortly after the outbreak of the war and ceased acting for those sanctioned. But this hasn't stopped them being heavily criticised by the press and politicians for having acted, quite properly at the time, for Russian clients.

Local Law Society Engagement. Improving engagement with local law societies across the country remains a high priority. The President, I. Stephanie Boyce, has been touring the country - including a visit to the Bournemouth Compliance Conference run by the BDLS.

We have had another virtual 'Town Hall' meeting where all local Law Societies meet to discuss issues of the day. And planning for the Local Law Societies Annual Conference 2020 on the 14th July is well underway.

Local Law Societies Connect. A peer to peer platform for local law societies to talk to each other and swap ideas and thoughts has also been launched. And guess what, the BDLS excelled itself by being the top posting local Law Society following launch. Well done us!

A whole series of other projects are underway, including agreeing a new **Learning & Development strategy** to improve the societies offering to its membership (whilst not challenging the offerings of our local Law Societies).

Oh, and a further raft of elections for Council members representing work type seats (employment, in-house, personal injury etc) and Characteristic seats (Women's seats, LGBT+) are about to start. Even if you haven't the inclination to put yourself forward, you do need to go onto the Law Society webpage and **register on MyLS**. You will then be prompted to say what your specialities are and be able to vote for your relevant Council member. As a bonus, you will also get more focused emails and information from the Law Society. Go on, do it now.

LAWCARE: ONLINE CHAT SERVICE

Legal mental health charity LawCare has extended its online chat service for legal professionals and will now be available every week Tuesday-Friday 9am-5pm. The charity, which offers free, confidential, emotional support to anyone working in the law, has been operating a helpline and peer support programme since 1997 and has supported over 10,000 people in the profession to date.

Elizabeth Rimmer, Chief Executive of LawCare, said: "We recognise that many people can't or won't pick up the phone to call us for a variety of reasons so we wanted to make it easier for people to reach out and get help with whatever is concerning them. We are keen to support anyone going through a tough

time, even if they just need to let off steam or talk through a situation, we're here anytime they need to talk. We don't ask for roll numbers or details of workplace and people don't have to give their name."

Anyone working in the law including support staff can contact LawCare for free, confidential, emotional support. Online chat is available at www.lawcare.org.uk. You can also call 0800 279 6888 or email support@lawcare.org.uk. The charity also has a team of peer supporters, people who work in, or have worked in, the legal profession who may have been through difficult times themselves and can offer one-to-one support, friendship and mentoring to those who need it.

LIFE IN THE LAW, WELLBEING AND UNHEALTHY COPING MECHANISMS

Earlier this year I spoke to Elizabeth Rimmer, Chief Executive of LawCare, about their first of its kind research "Life in the Law." Informed by feedback from over 1700 legal professionals the research found that most (69%) of participants had experienced mental ill health in the last 12 months, that legal professionals are at a high risk of burnout and that one in five had experienced bullying, harassment or discrimination.

I asked Elizabeth whether she was surprised by the findings?

"The burnout scores surprised me. We used a recognised scale (the Oldenberg Burnout Inventory) not anticipating that scores would be as high as they were. The intersectionality aspect confirmed what we know, in that the population is not homogenous - certain groups within the legal profession are more impacted by working practises and cultures e.g. junior lawyers, women, Black and Asian lawyers."

Do we see in the law culture wars being pursued elsewhere, with a younger demographic more comfortable talking about mental health and prepared to stand up and guard their wellbeing against people that have been part of a traditional law firm for a long time, putting all sorts of labels on wellbeing and sweeping them up into a bigger conversation?

"There may be an element of that. It is a changing profession. The pandemic opened up more conversations. Expectations of people coming into workplace are changing and we have a generation with a different perception of the working world out there. Wellbeing matters not only because of benefits to individuals but it gets into heart of legal work. To be a competent lawyer you need clarity of mind and focus. If your mental health is compromised you are going to exercise poorer judgement, make more mistakes, make poor ethical decisions and we see some of that coming through in SRA cases. Often a series of events have led people down that pathway. They have not set out to breach codes and be dishonest. Often there is a mental health component."

"LawCare was born out of a concern by the law society in the early 90's about how much solicitors were drinking and that there was a problem with using alcohol as an unhealthy coping mechanism for the pressures of life in the law, which led to us being set up as an independent charity in 1997. Perhaps in the 90s there wasn't the vocabulary to describe what was leading to using alcohol but there was a recognition that we had some problems. The issues predate the hyperconnected world and email. It is rooted in some of those cultural and practice issues in the law. There may be an element of society talking about the issues in a much bigger way colliding with the fact we often put a lid on what we see. There won't be a legal professional in the country who hasn't seen poor conduct in the workplace, seen people bullied and harassed. There are a number of factors but not just changing demographics. "Been there, done it, got the t-shirt, pull your socks up if you don't like it and leave" isn't going to wash anymore – just look at the challenge in retaining and recruiting in the law."

"We asked people what was the most useful measure to support wellbeing? What came out of that was "regular catch ups". We weren't expecting that to come through so clearly on the management aspect. On the other side we asked those in a managerial position how many had received training in how to manage others and the answer was less than half! We have a challenge in how we supervise and manage people in the law. What all organisations can be doing is a better job of managing people. You do not need to be signing people up for gyms, EAPS and Fitbits. What they want is time to sit down with their supervisor or manager and talk about work and what may be going on for them."


