BDLS ANNUAL GENERAL MEETING

4 JULY 2022 - CARLTON HOTEL, BOURNEMOUTH

This year's AGM was held at the Carlton Hotel and also streamed online.

We were delighted that The Law Society President, I Stephanie Boyce, was able to take some time out of her busy schedule to address our members. I Stephanie, being the 6th female President and the first President of colour, reflected on what she and The Law Society had managed to achieve during the last fifteen months.

When she took on the role, her mission was to leave behind a profession that is more open and diverse than the one she entered - improving diversity and inclusion was at the heart of her presidency. Accordingly, she has challenged those harmful attitudes that stand in the way of building an inclusive culture. She has been part of the City of London Taskforce involved in improving social mobility and, in this capacity, has hosted

numerous events with members to understand local challenges and help identify solutions.

She also informed members that The Law Society has also been hard at work influencing Parliament and Government on behalf of members and reported a number of positive outcomes from their lobbying work. In particular, the Overseas Operations Act – which became law in April 2021 – does not include a presumption against prosecution for crimes against humanity, genocide, torture, and war crimes, as was originally planned.

They also succeeded in protecting judicial discretion in the Judicial Review and Courts Act, which became law in May this year. Provisions that would have limited the remedies judges could award to successful judicial review claimants were removed from the legislation. Also, after years of tireless campaigning, we finally saw the first significant increase in criminal legal aid rates in a quarter of a century. Thy will continue to make clear to the Government that this rise must be the baseline, and not a ceiling, for rates increases, and I hope that with continued effort and engagement we will see further progress on this in the near future.

She was also pleased to see success in their efforts to persuade the SRA to delay the closure of the Solicitors Indemnity Fund.

She talked about the emphasis she has placed on young people and has been taking opportunities to go into schools, colleges and universities to speak to young people about her experiences and journey, and to demystify the law and the legal profession for them. She hopes by doing so she will help to encourage many more talented people from diverse backgrounds to pursue a legal career.

Mary Jackson, Director of Education and Training from LawCare, gave a short presentation. She reminded members of the support services LawCare provides including the helpline available 9-5 weekdays, live-chat Tuesday-Friday and email support accessible via the LawCare website www.lawcare.org.uk All their services are free and confidential and available to all who work in the legal community.

The main focus of her presentation was to summarise the findings from the research carried out by LawCare, whose results were published at the end of September 2021. The project was overseen by a team of academics from both the Open University and the University of Sheffield and the full report entitled Life in the Law may be read online at www.lawcare.org.uk It provides data measuring concepts such as BurnOut, Psychological Safety and Autonomy.

Mary also set out ideas for improving the culture and practice of law including the possibility of having a 9-5.30 working day, collective targets and regular diarised supervision.

AN UPDATE FROM MICKAËL LAURANS

- THE LAW SOCIETY'S HEAD OF INTERNATIONAL



Why we engage in international work?

There are many reasons why we, as Law Society of England and Wales, engage in international work but, first and foremost, it is because of the importance of international work and international legal practice to our profession and to our jurisdiction. Eleven thousand solicitors are



established outside of England and Wales; many more in England and Wales engage in cross-border legal work; 200 foreign law firms have offices in our jurisdictions; between 10 and 15% of newly qualified solicitors every year are foreign lawyers requalifying into our profession. These facts and figures, and many others, underline the importance of the international dimension.

What we are currently focussing on:

I. International market access

Our objective here is to increase (or maintain) market access for solicitors and law firms in key jurisdictions. We do so within a particular context: Brexit has meant the loss of access to the EU internal market but also the development of a newly independent UK trade policy. The UK government is involved in a number of Free Trade Agreement negotiations and bilateral trade dialogues with key jurisdictions for trade in legal services. Many of these constitute windows of opportunity for us to make the case for increased market access.

Recent successes have included:

- The grandfathering of UK LLPs already present in France and access to the French Foreign Legal Consultant scheme.
- The confirmation that UK LLPs can continue practising and that FIFO is authorised in Germany.
- The roll-over of the EU-Korea agreement into a UK-Korea FTA enabling 4 city firms to continue operating in Seoul.
- The establishment of a professional bodies' dialogue on legal services in the recent UK-Australia FTA.
- The inclusion of legal services as a priority sector in three bilateral trade dialogues (India, Nigeria, Malaysia).

I. Global legal centre

Our objective here is to promote (and maintain) the position of England and Wales as a truly global legal centre. This includes how we promote English law as governing law of choice in international contracts; England and Wales as a jurisdiction of choice for dispute resolution (litigation and ADR); the qualification of solicitors of England and Wales as a passport for furthering their international practice; and more generally the legal (and non-legal) expertise of our members.

Our current workstreams include:

• Further research on the determinants of choice of governing law and jurisdictions.



- Increased linkage with our policy work to influence the domestic factors impacting our international standing (e.g. business immigration rules, the judiciary)
- Competitive watch on what the competition is doing (NY; Singapore; International Commercial courts in Western Europe, Middle East, Africa and Central Asia)
- Influencing the Private International Law landscape post-Brexit (e.g. our work on the Lugano Convention; Singapore Convention on Mediation)

2. Promoting the rule of law and standing for lawyers at risk internationally

Thirdly, we stand for the rule of law and for lawyers at risk internationally. This goes to the core of what being a lawyer is and members expect us to have a strong public interest element to our international work beyond international practice of law. This is structured through two programmes.

Our first rule of law programme concerns "Lawyers at risk", i.e. legal professionals who are threatened, sometimes in their lives, for doing their work in representing and defending clients.

Our second programme concerns capacity-building where, subject to external funding, we support international stakeholders (e.g. a foreign bar or the judiciary) in meeting a particular development request or objective (e.g. training of judges or bar officials; setting up a new bar association in a newly democratising jurisdiction; raising awareness on rule of law issues).

Next Year

We intend to continue and to strengthen the work I have mentioned above, but we are also currently considering our business plan for the next three years and we intend to particularly review and focus on how we support members to make the most of international opportunities.

Our international workstreams are not just about the largest firms, based in the City, but also about the smaller firms throughout England & Wales that provide cross-border legal services, and we want to ensure that they can make the most of international opportunities; networking opportunities, connecting people globally, and bringing delegations to not just London but to the rest of the UK. It isn't that we haven't done this before - We already collaborate with law societies around England & Wales and many attendees of today's Forum have all worked with our International team in the past - but that we want to review how we have engaged previously, provide renewed focus, and deliver more value.

In the meantime please do not hesitate to reach out to our **International team** should you want to discuss any international issues that are affecting your society or your members and we will endeavour to do the same where our work concerns your society.

LEWIS HENZELL PARKYN (1942-2022)



It is with great sadness that we advise that Lewis Parkyn passed away on 12 July 2022.

Lewis was a very active and supportive member of the BDLS and a well-known and well-regarded local practitioner. Lewis's support for the BDLS started early in his career. He was Chairman of the Young Solicitors Group (now the Junior Lawyers Division) and then President of the main Society in 1990/1. He was an enthusiastic committee member and a long serving member of the committee responsible for the monitoring of Trainee Solicitors. He was a keen supporter of the Society's various activities, Dinners, Lunches and European trips.

Lewis served his articles with Rendall Litchfield & Co in Bournemouth, qualifying in 1964, where he remained to become a partner. He left in 1971 to join Dickinson Manser & Co in Poole as a partner, where he remained until he retired in 2002.

Lewis had a wide experience of both contentious and non-contentious work. Whatever he did was undertaken meticulously and with enthusiasm. His motto was 'always put the client first' and, consequently, he had a loyal following of clients.

Lewis was senior/managing partner of Dickinson Manser for 16 years until 1999. He was an excellent manager with a keen eye for detail and the preservation of standards, but he was always very fair in his dealings with staff and clients. He never believed in asking anyone to do a job he was not prepared to do himself.

Alongside his work in the office, Lewis had a busy professional life. He was Undersheriff of Dorset, a member and then chairman of the Rent Assessment Committee, a Trustee of the Poole CAB and solicitor to The Poole Harbour Commissioners, in each case for over 20 years.

Beyond his professional activities Lewis was, at various stages in his life, keen on scouting, boating, and walking. He was an active member at Parkstone Yacht Club (where he was nominated 'Volunteer of the Year' in 2019). He had been a voluntary warden at Brownsea Island from 1962 to 2021, for which he received the BEM in 2013. He was an active member of the Poole Friends of Arethusa & Shaftesbury Homes, a charity which enabled disadvantaged youngsters to pursue sailing.

Lewis was always courteous, unassuming, fair and reliable. In short the model of a provincial solicitor of his generation, who took a very willing and active part in professional life and the life of his community.

Lewis's first wife, Ann, died suddenly in 1999. He is survived by his second wife Jan, the two sons of his first marriage, Andrew and Christopher, and three grandchildren, Ann, Ian and Joe.

Lewis was diagnosed with cancer in 2019 and, although he was advised that no further treatment was possible, he continued to lead an active life until just a few weeks before his death, when he was admitted to Forest Holme Hospice where he died on 12th July 2022.

COUNCIL MEMBERS ROUND UP - AUTUMN 2022

Practicing Certificate Fee Rise - thanks for the support.

67% of the solicitors who responded to the Law Society consultation agreed with the proposal that the Society's share of the P.C. fee should increase by 15%. In fairness, it had been reduced by 10% for the last two years due to the pandemic and the rise is only around £11 per practicing certificate.

If the increase is accepted (and it has yet to be approved by the Legal Services Board), it will help the Law Society get back on track on the work it needs to do.

The Law Society receives around 30% of the overall Practicing Certificate – the rest goes to the Solicitors Regulation Authority (SRA) and the several other regulators that now oversee us, and one fears they will also be looking for increases.

Local Law Society Conference - Prize for Mandy

It as great to be involved with the organisation of the annual conference for Local Law Societies. The debate about whether this (and many of our other conferences) should be virtual, in person or hybrid continues. Views appear evenly split. Whilst in person conferences have my vote, it is fair to say numbers at virtual events are larger.

It gave me much pleasure to round off the conference by awarding a prize to our very own Mandy Heath. The prize was for the three most engaged Local Law Society members based on the number of posts they had made on the new Local Law Society Connect platform launched earlier this year — this enables local law societies to exchange messages and ideas for events and common issues. Great to have the BDLS up there in the top three nationwide.

New faces at the top in Chancery Lane

We have just appointed a new Chief Executive. His name is lan Jeffery and he is a Solicitor and former Managing Partner of Lewis Silkin. After a period of non-solicitor C.E.O.s, someone with a background in a solicitor's practice could bring some beneficial insights to the role and the society.

October will see our current President I. Stephanie Boyce hand over the role to Lubna Shuja, a sole practitioner from Birmingham. I believe she will be excellent. Engaging with and supporting Solicitors will top of her agenda.


