As I mentioned in my speech at the AGM, my aim this year is to get our membership re-engaged and re-acquainted after an unprecedented 16 months of lockdown. I was therefore keen to get my Presidential year off to a flying start with some social events with an outdoor flavour to encourage members out again. Indeed, I would encourage all members to attend as many of the Society's social and sporting events as possible as they are always fun and meeting other members at leisure can only be conducive to good relations within the profession locally.

The first social event of my year was the BDLS walk for Leukaemia UK, which is my charity for this year. I am pleased to say that the event was well attended, managed to avoid the rain and made for an enjoyable morning out for all participants and their dogs!

#### **SRA Accounts Rules**

Operating a client's own bank account – 2 years on.

Deemed a high risk area by the SRA, in brief firms must: Obtain bank statements at least every 5 weeks; then Reconcile the statement balances to the cash book and client ledger balances;

Maintain a central record of all bills of costs.

#### Challenges?

Can the firm integrate these into the accounting system? What about transactions initiated by the appointee? Possible delays obtaining bank statements - no online access?

#### **Ethics Guidance**

The SRA recognised these challenges, issuing further guidance in November 2019. Key points:,

If able to - then comply;
If unable to - should at least keep the following:

Central register of client own accounts operated; Separate record of transactions carried out by the firm; Record of the firm's bills relating to these matters.

While there is some compromise in the guidance note, the overriding objective is to ensure the money in these accounts is not at risk. Control arrangements to consider might include:

#### SHAREDAMBITION

Applying the same payment authorisation controls that are used for payments on firm's client account.

Including in internal (COFA) compliance reviews;

Including procedures and controls in internal manuals;

Future changes?

Rule 10.1 and the guidance is under regular review by the SRA. Firms should ensure, where they operate such accounts, they keep fully up to date with any further developments in this area.

#### Membership Engagement

There have been some great steps forward with the engagement between the Law Society and the 104 local Law Societies that are spread across the country: Every local Law Society now has a named contact and an annual one-to-one engagement meeting. I was happy to join in the one that took place with the BDLS.

A Virtual 'Town Hall' meeting took place where every local law society was invited to spend a minute explaining what their major concerns were. It was fascinating to listen in as societies from across the country – some with thousands of members and others proud to have twenty members – told us their views. Court closures, criminal legal aid, PI insurance, access to justice issues came from all corners. Well done to our President, Neil White, who spoke about his concern over the lack of respect for Solicitors – a theme picked up by a number of subsequent speakers.

A virtual President's and Secretary's Conference attracting record numbers and featuring many local law societies telling of their challenges and successes during lockdown. Thanks to our past President, Mark Kiteley, who sat on one of the panels and told of BDLS's accomplishments

As well as local law societies, a review is underway to improve the relationship between the Law Society and the various sections and divisions that exist - such as the Woman's Division and the vital Junior Lawyers Division

#### Practising Certificate

In consultation with the profession, most solicitors indicated they were happy with the Law Societies' share of the practising certificate remaining unaltered. Bear in mind only about 30% of the fee goes to the Law Society with over 50% going to the SRA (Solicitors Regulation Authority) and the balance between the many other regulators we are now obliged to fund (Legal Services Board, Legal Ombudsman, Solicitors Disciplinary Tribunal and the Financial Conduct Authority)

#### SIF Extension Victory

Much passion and debate has taken place over the insurance run off for sole practitioners. If you close your practice without a successor practice, the rules require you to buy six year run off insurance. But what happens when that six years comes to an end? For many years, the balance of the funds held following the closure of the SIF has been used to offer protection, but the SRA announced that protection is now ending. After much lobbying, they were persuaded to extend it for a further year. But with no appetite by the insurers to provide further cover, a long term solution is still uncertain. Meanwhile, of course, the hardening professional insurance market is causing concerns for firms of all sizes.

#### Elections Galore

Following decisions about the re-arrangement of Council seats (reduced geographical seats and increased specialist subject seats) and the introduction of the rule that no Council member can stand for more than twelve years, up to half of Council seats are up for re-election. When Council next meets after the AGM in October, membership will be dramatically changed with many of the long standing and experienced members gone. The idea is to make Council more representative.

#### Do you open your emails?

No-one can say the Law Society does not try to engage its members. It has a multitude of Facebook, Twitter and Linkedin pages and even Instagram platforms. It also sends out many, many emails – about 19 million in a year – of which it is estimated 14 million remain unopened. A new drive is underway to try to streamline and target its communications!





#### **JUNIOR LAWYERS DIVISION**









As restrictions have come to an end this summer, so the BDJLD looks to move into a post-lockdown period where we must balance the interests of our members who are keen to resume in-person events with those who understandably remain cautious of large in-person meeting. #### Introduction

Recent changes to the CQS standard brought about a new onsite assessment regime which accredited firms will be subject to as part of demonstrating their compliance with the CQS Scheme Rules.

The Revised Domestic Abuse Bill has almost completed the various stages within the Houses of Parliament, and once it receives Royal assent, there will be a need to ensure that there is implementation across England and Wales, swiftly, and appropriately. It will be changing various areas of law, principally family and children law. #### BACK TO LIFE: RETURNING TO NORMALITY AFTER LOCKDOWN

As restrictions lift, many of us will be looking forward to getting back to 'normal', which for some of us will mean a return to the office. Despite restrictions lifting the reality is that we simply will not bounce back to our normal pre COVID-19 selves right away after spending the best part of a year at home. #### Feel the feelings

After a year of being in survival mode with a low level (and for some a high level) of stress in the background all the time we have a lot of feelings to process as things get back to normal. Whilst some of these feelings will be positive such as excitement and relief, we are also likely to be fearful, nervous, and anxious of the changes coming and how we will deal with them. We may have residual feelings of grief, sadness and anger for everything and everyone we lost during lockdown. Focus on what you ARE feeling rather than what you SHOULD be feeling – suppressing your feelings and emotions won't help.

#### **Expect to feel tired**

It's best to take things slowly and to leave some clear space in your calendar, as once you are back in the office you will initially be very tired and need time to process the change, rest and reflect. On the plus side, our brain thrives on physical activity and novelty, so after a few weeks hopefully you will feel energised as the fog of the last 18 months begins to lift.

#### Be prepared for setbacks

It's likely that there will some bumps on the road back to normality. Recognise that best laid plans often have setbacks,

so keep an eye on how you are feeling, how you are coping and be kind to yourself.



#### Don't rush into any decisions about work

Don't make any decisions about committing to a return to the office full time straight away if you can help it. You need to really think about what's best for you and your situation, everyone is different. Be confident to share your feelings about returning with your line manager or HR. You may not want to work the same hours as before or you might want to request to work permanently at home. Make the new normal work for you rather than defaulting to what used to be.

#### Look after yourself

Many of us have got into good habits in lockdown and are managing to sleep better, eating right and getting exercise. Try not to let these healthy habits slide once you're back in your usual routine, as they help to keep us mentally and physically well.

#### Share how you are feeling
