## THE PRESIDENT'S COLUMN

At an AGM some years ago, Past President John Newbold spoke of the need for local firms to encourage and support their solicitors in joining our Society and taking the most onerous roles within it. I have been asked to speak to the strength of our society at the national Presidents and Secretaries Conference in Chancery Lane in June, and over the course of the next 12 months I will have the privilege of representing BDLS at numerous events both domestically and abroad. I will report on the first of these in the next magazine. For now, may I thank you again for your confidence and support – I will do my very best to deserve it!

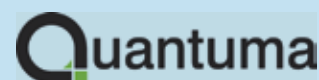

MEMBER'S REPORT**

- At a strategic planning weekend Council received presentations and research around membership experience, engagement with, and expectations of, the national Law Society, and tested propositions around improved relationship management initiatives. The website architecture needs improvement to make it more intuitive and to reduce the number of 'clicks' per page needed to find content. Pilot projects are complete and a new website is planned for launch in the Autumn.
- Annual report for year ended 31 October 2018. The Society secured coverage on television and radio broadcast media 105 times and appeared in national and regional press 2,100 times. The Society was mentioned positively in 'Hansard' 340 times, gave oral evidence before 13 parliamentary select committees and tabled 45 parliamentary written questions. In-carriage advertisements on London underground reached 30m passengers; the 'Gazette' online received 17m page views. The practice advice service handled 23,000 enquiries and the library assisted 8,500 members with legal research. The professional development centre produced 94 webinars viewed by 9,500 members. The president signed 13 Intervention letters in support of persecuted lawyers around the world to promote human rights and the independence of the legal profession.
- The Council authorised delegation of the sign-off of the Law Society Group annual accounts for the year ended 31 October 2018 to the Board. (votes: for, 57, against, 0, abstention, 1) For accounting purposes the Law Society and the SRA are considered a single entity.
- Delegated financial authorities. The Council approved an updated policy authorising staff to spend money up to approved limits, dependent upon grade and consistent with the policy and the requirements of the external auditors. Spend in excess of £1,000,000 requires advance approval from Council. (votes: for, 40, against, 14, abstentions, 6)
- Brexit. The Society continues to provide support and assistance to members to cover all eventualities whilst stressing the role of the jurisdiction as a global law centre. Initiatives promote the law of England and Wales as the international law for contracts and the courts of England and Wales as the preferred forum for dispute resolution and arbitration. # FAMILY LAW SYMPOSIUM EVENT - IN CONJUNCTION WITH BOURNEMOUTH UNIVERSITY

On behalf of the local Bournemouth and Poole Collaborative Family Lawyers Group ('POD') I co-ordinated and took part in an event at the University on 6 March designed to showcase the various dispute resolution alternatives available to separating couples.

The event took place in the Share Lecture theatre at the University before an audience of around 50 students and local legal and financial professionals – including BDLS President, Edward Holmes - and featured four role play scenarios to demonstrate mediation, collaborative, arbitration and court processes. The fictional couple, Ian and Vicky Humber, were seen engaging in mediation with Michelle Bettell, mediator from Steele Raymond, to resolve their arrangements for time with their three children, resulting in an interim arrangement. Michelle also provided information about how the process works and the same issues were then played out before His Honour Judge Richards with students providing submissions on behalf of their clients. The outcome was less civilised with the couple being told by the Judge that they should seek mediation to resolve matters! The unpredictability of the outcome in litigation was demonstrated well and the contrast between that and the couple who had coped with the challenge of the mediation process to reach a solution was true to real experience.



The second part of the evening saw our couple, Vicky and Ian, attempting to resolve their financial matters including housing, pensions and maintenance in a lively collaborative session. Students once again took up the characterisation of the couple as they received financial information from expert, Cheryl Bowden, whilst Jonathan Talbot (Laceys) and myself provided them with guidance and advice, and management of expectations. Having moved forward over a bowl of grapes, the session ended on good terms with a clear forward plan and the expectation of a satisfactory solution. The same issues were then put to Arbitrator Simon Lillington, who gave an indication of his award to the student advocates and their clients who experienced once again having control of the outcome taken away and a result imposed which was perhaps not what either wanted (not a clean break for Ian and not keeping the house for Vicky). Simon also gave the assembled audience a summary of the arbitration process itself and the history of its development into the family law arena.

The event was well received by the audience who then had the opportunity to visit the University's impressive new law faculty floor in the Weymouth building, complete with mooted facilities, for light refreshments. I would like to express my thanks to all members who attended the event and offered support and assistance to it throughout, as well as to the staff and students at the University

## EUROPEAN LAW CONFERENCE - BUDAPEST

**Q. Have you always lived in the Bournemouth area?**

## LIABILITY FOR PROFESSIONAL NEGLIGENCE

### SAAMCO REVISITED

Practitioners in the field of professional negligence (or “Friends of SAAMCO” as they are often known) will be familiar with the twists and turns in the common law since *South Australia Asset Management Corp v York Montague* [1997] AC 191 (SAAMCO). The Court of Appeal has now come full circle and re-stated the familiar principles in *Manchester Building Society v Grant Thornton* [2019] EWCA Civ 40.

SAAMCO concerned the liability of a valuer for foreseeable market related losses suffered by a lender who provided a loan on the basis of the valuer’s negligent valuation. The House of Lords held that the valuer was not liable for all the foreseeable losses suffered as a result of entering into the loan transaction, but only for what the lender would have lost if the valuation had been correct. Lord Hoffmann said “...a person under a duty to take reasonable care to provide information on which someone else will decide upon a course of action is, if negligent, not generally regarded as responsible for all the consequences of that course of action...”.

From this we derive the distinction between those whose duty it is to provide accurate information to their clients and those who advise on the wisdom of a particular course of action. Since the law assumes a successful transaction, where the professional person is a provider of information, if negligence is established then the liability is limited to the difference between the price paid for that transaction and the price that would have been paid but for the mistake, but not all the consequential losses flowing from entering into it.

SAAMCO has been considered in a number of subsequent cases, including *Nykredit* [1997] 1 WLR 1627, *Platform Home Loans* [2000] 2 A.C. 190, and *Aneco Reinsurance* [2001] UKHL 51 but in *Hughes-Holland* [2017] 2 WLR 1029 Lord Sumption questioned the distinction between advice and information. This led to a different approach being taken by the trial Judge in *Manchester Building Society*. The judge said “It is now well established that when assessing a defendant’s responsibility for losses the court must, having determined that the defendant’s negligence was an effective cause of the losses”.

The Court of Appeal disagreed. Lord Justice Hamblen said that in order to recover the foreseeable loss is first necessary to show that it is an “advice” case where “it is left to the adviser to consider what matters should be taken into account in deciding whether to enter into the transaction. His duty is to consider all relevant matters and not only specific matters in the decision”. Unless the adviser is “responsible for guiding the whole decision making process” it is an “information” case and the adviser or information provider is not responsible for all the foreseeable financial consequences, only for the foreseeable financial consequences of the information or advice being wrong. This was an “information” case rather than an “advice” case and that for that reason rather than the one found by the Judge, the claim failed.

# THE SORCERER'S SOLICITOR'S APPRENTICE!

Those of us that have represented the Society or their business at local schools' careers days will have noticed an increasing number of anxious parents asking about apprenticeship opportunities. It is little wonder, when the typical student will graduate with £50,000 worth of debt! A number of local law firms and other businesses already offer apprenticeships within their marketing or accounts teams. What I believe is presently underutilised is the solicitor apprentice as a route to qualification as a solicitor.

Put simply, an apprenticeship combines practical training in a job with study. The government has set a target of 3 million apprenticeship starts between 2015 and 2020, a target supported with the apprenticeship levy payable by employers with an annual pay bill in excess of £3 million. The levy builds a digital fund which the employer can then utilise to pay for apprenticeship training.

A solicitor apprenticeship will last 6 years, with 20% of that time engaged in study leading to a recognised qualification, an LLB in Legal Practice and Skills. The local universities are yet to offer the academic component, but the University of Law do, through a combination of weekly submitted tasks, and an assessor visiting the work place to monitor progress and offer mentoring support.

The cost of the academic component is £27,500. A levy payer will spend some of their digital pot. Those firms who do not pay the levy need not miss out. They pay just 10% of the bill, with the government picking up the rest. Over 6 years the cost is only £38 per month! As with other routes to the profession, a solicitor apprentice will undertake the Solicitor Qualifying Examinations (in years 5 and 6) and one would expect the cost of these to be met by the employer. The final cost of SQE are yet to be published, but it seems sensible to budget £3750-£4500.

The apprentice is paid a salary, with the minimum hourly rate of £3.90 rising to the national minimum wage when the apprentice is 19 or over and completed their first year. Of course, one would very much hope that market forces encourage a more realistic wage as employers compete to recruit the best candidates.

Who will suit an apprenticeship? The academic starting point is 3 A Levels at Grades A-C or equivalent, and 5 GCSEs including Maths and English or equivalent at A-C (lev 4 or above). It will be an attractive option to somebody for whom the cost or other circumstances mean the traditional route is out of the question. However, it is important that the apprentice knows that they want to be a solicitor. Many people at 16, 17 or even older lack a clear idea of their preferred career path. For them, 6 years may feel like a very long time.

From an employer's point of view, it is difficult to think of a "downside", provided rigorous due diligence at interview ensures the candidate is the right fit for your firm. There appear to be few alternatives that offer such an affordable way to reach into this greatly extended talent pool. The directors at Rawlins Davy have recently shortlisted for a solicitor apprenticeship to commence this September, and the calibre of candidates has been outstanding. Choosing between them will not be easy. Perhaps given the cost, we will not need to!
