It hasn't gone unnoticed in recent months how the SRA are taking robust enforcement action against practices who are failing to comply with their Money Laundering legislation obligations in practice. Whilst we are all likely to be aware of the failings of some practices in not producing a compliant Practice Wide Risk Assessment or AML policy, or they have failed to evidence an appropriate client/matter risk assessment has been carried out, many other gaps exist in day-to-day operational compliance.
