He has been the Lead Regional Judge for the Court of Protection (South West), a Commissioner of the Judicial Appointments Commission and former Course Director at the Judicial College (Family). Before being appointed he was a Solicitor and Partner in the firm of Davis Simmonds &amp; Donaghey specialising in Public Law Proceedings and a member of the Children Panel. He is editor of A Practical Guide to Family Proceedings and one of the contributors to The Dictionary of Public Children Law</p>
