Changes to the CQS standard from May 2019 saw the introduction of both Desk Based Assessments and Onsite Assessments.

Following the CQS onsite assessment pilot of late 2019/early 2020 and the subsequent interruption caused by the Covid pandemic, the formal commencement of the new CQS assessment regime is imminent once Covid allows, likely in spring 2022.
